
• Rick, Jill, Linda, Marli, Obe, and others gave specific examples of Kerry's leadership and vision for NRCC

#### 12:20pm: Review and Approve Minutes

#### 12:21pm: Finance Manager Update

- Clare gave an overview of NRCC's finances and past budgets
- Year-over-year from FY13-FY22 budget has increased from core funding (VAAFM) and other grants (AOI). Kerry began as Administrator in 2012
- Now in FY22, funding coming from a variety of sources new and old, including state, federal, private sources



- Clare gives overview to preliminary budget (materials were provided prior to today's meeting)
- NRCC expects continuation of many programs, with new funding in the form of RCPP for instance.
- Current funding is heavily state-based (97.8%), but this is expected to transfer towards federal funding with the new RCPP grant especially.
- Rick asks about how many FTE positions are supported with current personnel, Clare estimates this currently fulfills 3- 3.5 FTE positions, but this is expected to increase over the next year. Council is looking into an additional administrative support position for grant support, invoicing and other financial support. New position would also aim to support district administration directly (budgeting, quick books, human resources, etc)
- Linda makes a motion to approve the budget, seconded by Richard. Discussion continues.
- Richard asks about total award (~\$6M) vs. FY22 budget (~\$2.2M). Clare explains that the award represents multiple fiscal years and the award total may be spent previously, spent in FY22, or spent in the future
- Motion passes
- Other updates -
  - With Kerry's departure, Clare goes over a few administrative changes that are being made including

- updating Council's mailing address, various registrations (SAM.gov contact information etc) and transferring these pieces of information to Clare.
- Jill introduces Emily Nummer as the new Agriculture Programs Manager as Emily has not attended the
  previous (March) meeting. Emily will be (or has) taken over Ag programs and grants held by NRCC and
  VACD, including some wetlands-specific programs. Introductions and welcomes from the Board are
  given to Emily.
- Rick and Marli highlight possible discussions in the future and/or strategic planning to pursue opportunities, partnerships, and collaborative opportunities. Jill adds that some of this process is underway, and those conversations are happening at the local level, but can look into
