# Grant Proposals, Approvals, and Updates

VAWQP Regional Coordination – Performance Notice Approval ((Michelle and Clare)

The board reviewed letters in response to performance challenges encountered with Bennington and White River districts. Kate felt the letter is harsh and might be counterproductive suggesting a gentler tone.

Richard made the motion, seconded by Bill to approve corrective action be taken with White River and Bennington Districts and that the NRCC administrator is authorized to work with the committee to move that forward. Upon a call for a vote, all were in favor.

Other grants updates





Clare discussed Core Services strategy for the new year. \$250,000 in one time funding is expected from the legislature and two spending strategies have been discussed:

- Council would retain money to hire a CPA for friendly audits, or
- dividing the money equally among districts.

Michelle noted there was good support in the legislature for the districts and given the budgeting challenges, was happy to see this increase in funding.
